
We have Moved!

On Tuesday February 10th Emergency Services officially moved into our new offices and dispatch center. We are now located at 520 Justice Dr. in Lebanon (next door to our old building.) All of our contact information has remained the same but our mailing address has changed.

If you need to stop by the offices during normal business hours you may use the main entrance in the front. If you are stopping by to visit dispatch at any time we are asking that you use the rear entrance so we can buzz you in. This entrance is located on the back side of the building that faces the common pleas building (see picture below). To get to this entrance, use the Board of Election's lower parking lot and to the left of the sally port doors is a stair case that will lead you to the rear door. When you arrive at any time of day, you will need to call the Dispatch Supervisor at 513-925-1574 or call us via radio so they can let you in. If you were unable to make it to our open house and would like to see the new dispatch center, we invite you to stop by and the on duty supervisor will be happy to show you around.

Did You Know?

Clinton County Radio System on Our Consoles

Last month we looked at station numbering in Butler County. We also have Clinton County Fire Primary on our consoles and can hear their units responding on calls. Clinton County has numbered districts that often cover multiple communities in addition to unit numbering. Districts are as follows:

District 1 - Wilmington Fire Department - units: E1, L1, TO1, R1, E2, E3, etc.

District 2 - SRWW Joint Fire District (Sabina, Richland, Wayne, Wilson) - units: E25, E26, T27, etc. (Fire/EMS Dispatched by Wilmington Dispatch)

District 3 - Clinton-Warren Joint Fire District - units: E61, E62, B63, S67, S68, etc.

District 4 - Clinton-South Joint Fire District - units: E48, T46, etc. (No EMS, Covered by Blanchester EMS)

District 5 - Chester Twp-New Burlington Fire Department - units: E51, T52, S54, S55, etc.

District 6 - Clinton-Highland Joint Fire District - units: E12, B15, T17, etc.

District 7 - Martinsville Fire Department - units: E77, T76, R9, etc.

District 8 - Blanchester-Marion Twp Fire Department - units: E83, E88, L80, T86, etc.


Blanchester EMS - units: R101, R102, R103 (Fire is dispatched by Wilmington Dispatch)

District 9 - Port William Fire Department - units: E93, E94, L96, T90, etc.

Note: We have district 1, 3, 5, 7, 8, 9 units in CAD. Also, some departments refer to EMS units as "Rescue" instead of "Squad" or "Medic".

Time to Spring Forward

Daylight Savings time begins on Sunday March 8th at 2:00AM. Don't forget to set your clocks forward one hour before going to bed Saturday night. Also, while you are setting your clocks, this is a good time to go ahead and change the batteries and test all of your smoke detectors. Fire departments encourage you to change your batteries in the Spring and Fall when changing your clocks. Smoke detectors are something we always assume are working but this is a good time to make sure they actually are.



Warren County Tactical Dispatch Unit (TDU)



The Warren County Tactical Dispatch Unit (TDU) is a group of five experienced dispatchers assigned to the Warren County Tactical Response Unit (TRU). The group consists of dispatchers from Warren County Communications, City of Franklin Communications and Springboro Police Department. After being selected as tactical dispatchers, they receive hands on field training. Their job is to help alleviate some of the stress and duties of the incident commander, tactical commander, and the critical negotiating team

while on an active incident. The TDU has been utilized to assist TRU with critical incidents, high risk warrant services, and special details. Dispatchers are a key component in supplying, relaying, and keeping track of everything that goes on during one of these high-stress incidents. The TDU members on scene also help to relieve some of the extra duties created inside the dispatch centers. These dispatchers are "on-call" for rapid deployment at any given time and will respond to the scene with the mobile units. All of the members of the TDU have years of dispatch experience.

Jennifer has been serving the Springboro Police Department for the past 15 years, starting out as a dispatcher and is now the Office Manager. For the past seven years Jennifer has been part of the Warren County Tactical Dispatch Unit which is part of the Tactical Response Unit where she was promoted to Team Leader.

Jennifer is married to Warren County Sheriff's Office Sergeant Shaun Embleton. They have been married since 2006. When she isn't working or serving on the Tactical Dispatch Unit she enjoys relieving her stress by working out.

When asked her most memorable call, she recalled two separate and unique incidents. "I'm torn between two, both involved pursuits. The first I was dispatching when one of our officers got in a vehicle pursuit that went into Dayton. About half way into the pursuit, he lost radio contact. We continued contact via cell phone, while I still dispatched our other units on the radio, handled all other incoming calls, and continued to try and get him backup from another agency. The second, I was on a ride along with another one of our officers. The suspect ditched the car and they got into a foot pursuit. Due to unfortunate events in our dispatch center, I ended up taking over dispatching from the cruiser."

Thank you, Jennifer for your service to not only Springboro Police Department, but also to Warren County as a whole. We look forward to many more memorable moments with the years to come.



Call of the Month

On Friday February 20th, Dispatcher Ron Kronenberger was sitting Police Primary 1 when Warren County Deputy Jonathan Pittman called out that he was involved in a head on crash at 5780 E US RT 22. Dispatcher Kronenberger immediately had other units dispatched to the call and had Fire and EMS dispatched as well. Deputy Pittman told Ron that it was a head on crash involving several vehicles. He also advised that he was injured but was going to check on the other people involved in the crash. Ron continued to update the other units. Deputy Pittman then said that there were no other injuries but he had a face laceration and bleeding from the eye area. Deputy Pittman was transported to Bethesda Medical Center, suffering minor injuries.

Calls involving our road units are always stressful from start to finish. Ron did an outstanding job while remaining calm and getting units dispatched, as well as keeping up with the other calls that were coming in. We would also like to wish Deputy Pittman a speedy recovery.
