What is EMA?

Warren County Emergency Management Agency (EMA) is the organization charged with public education, notification & warning, and tasks associated with the 5 phases of emergency management.

The Goal of Emergency Management is to:

- Protect the community from threats and hazards
- Reduce the loss of life
- Minimize property loss and damage to the environment

Warren County EMA's Essential Functions

Citizen Preparedness:

- Ensure resiliency in the communities
- Public Education campaigns, social media presence, seminars, exercises, etc.

Emergency Planning:

- Required: County Emergency Operations Plan, Hazardous Materials Response Plan, Hazard Mitigation Plan
- Other Plans: Disaster Recovery Plan, Debris Management Plan, Storm Ready Accreditation Plan, Continuity of Operations Plan, and other various plans for emergencies & disasters.

Emergency Response:

- Running of the Emergency Operations Center (to coordinate resources and recovery opera-
- Liaison between local and state/federal agencies

Recovery Operations:

- Disaster Recovery
- Damage Assessment (requirement for funding to help rebuild)

Mitigation:

- Apply for grants
- Make communities safer



Local Emergency Planning Committee:

- Part of Emergency Planning and Community Right-to-Know Act (EPCRA)
- Tracks hazardous materials storage in the county

Warren County EMA Trains Schools on Family Reunification

On Sept 6th, Lesli Holt from Warren County EMA provided a course on school evacuation and family reunification to local school districts in Warren County. The course focused on the importance of organized evacuation and reunification planning and used real-world examples from the Warren County Career Center full scale exercise earlier this year and lessons learned from other school evacuations.

Course participants were able to ask questions about planning components, share ideas about communications and accountability of students, and participate in a tabletop exercise that tested portions of their evacuation and reunification plans.

Did You Know?

The Importance of Damage Assessment

Following a disaster, there is a strict timeline of assessment to be following in order for a jurisdiction/county to receive a declaration (to provide financial assistance). If damage assessment is not conducted quickly and thoroughly, the jurisdiction/county will miss out on critical funds that are required to help homeowners and businesses recoup their losses.

During severe weather events, Warren County EMA staff consistently monitor weather radar, National Weather Service briefings, and other sources in an effort to gather situational awareness about the potential impact of the event to the county. It is imperative that during or immediately following a disaster jurisdictions report any known or suspected damages to structures or to infrastructure so that EMA can produce a report that will capture the county impact in a timeframe that will meet state and federal declaration deadlines.

Damage assessment process:

- Jurisdictions report known or suspected damages.
 - This is as easy as reporting the address and damages sustained to the EMA so their staff can follow up.
- EMA will deploy damage assessment teams to visit each address and capture data to quantify the damages. Teams use standards set by FEMA and the State of Ohio to ensure consistent damage reporting.
- If total cost of damages meets the state or federal requirement, the state sends formal teams to help assess the damage costs and work with homeowners. A state or Presidential disaster declaration can be requested, opening up funds to assist communities rebuild.
 - If damages do not qualify for state or federal assistance, EMA will track the flooded areas, and meet with a
 coalition to determine if mitigation actions can be taken to reduce the likelihood of flooding or reduce future
 damages.

Canadian warrant and stolen property information is no longer available in NCIC until further notice.

The RCMP (Royal Canadian Mounted Police) has ceased these entries and maintenance of Canadian criminal justice information in the NCIC (National Crime Information Center).

You can inquiry individuals and property through the interface between NLETS (National Law Enforcement Telecommunications System) and CPIC (Canadian Police Information Centre) to receive Canadian criminal justice information.

WQ for Persons VQ for vehicles CAQ for articles CGQ for guns CSQ for securities CBQ for boat files




Lebanon High School Career Experience Students Tour EMA & Dispatch
