Dispatcher Gives Life-Saving Instructions

On January 31, 2020 we received an email from Deputy Chief, Billy Goldfeder with Loveland Symmes Fire Department. He heard a squad run dispatched to his neighbor's home, so he ran over to help. The 22 month old baby was blue and barely breathing. Goldfeder wanted to pass on that the baby ended up breathing on his own and was transported to the hospital. *From my brief observation along with what Mom (Kris) said, your dispatchers were exactly as you would expect: caring, professional but also very direct in providing emergency instructions to an extremely frantic Mom and Dadboth justifiably upset and scared.*", said DC Goldfeder. Traffic Stop-Pursuit-Foot Chase-Arrested

February 1, 2020, Maineville Police Department's Captain, Scott Aronoff sent out a press release reference a traffic stop that led to a pursuit, two crashes and a foot chase. The driver was originally stopped for improper display of a license plate. The female driver failed to show proof of a valid driver's license and kept putting her vehicle in drive. Maineville requested Hamilton Township Police Department for backup and when they arrived, the driver took off. HTPD pursued the vehicle for about two miles when the driver crashed into a yard, backed up and took off again and almost hitting a Warren County Deputy. The female driver then crashed into a ditch and attempted to flee on foot, but was tackled and arrested. No officers were injured or law enforcement vehicles damaged. The communication Center was thanked for their assistance and professionalism. Great job everyone involved!

Deputies and Dispatcher Help Elderly Male

On February 2, 2020 a call was dispatched to the Sheriff's Office for a possible intoxicated driver. Soon after Deputy Bens confirmed that the driver was an 83 year old male from Springdale, that was lost and confused. Deputy Grossenbaugh, Vonholle and Bens all made sure he made it home safely. In the meantime, Dispatcher Stacy Ryan contacted Ohio State Patrol's Intel division and was able to locate the male's son. The elderly male has early onset of dementia and after this scare he was going to get him some help. Excellent job by all involved!



We are in the process of updating the WARREN COUNTY UNIFORM ROBBERY RESPONSE PLAN FOR FINANCIAL INSTITUTIONS. Updated information saves time in the event of an emergency and we are asking for your help. In the past we have called, faxed and sent letters to the financial institutions to get updated information. While some institutions have updated their information, there are many that are reluctant to give out this information due to the ongoing number of scams.

We are asking you to take this opportunity to reach out to the financial institutions within your jurisdiction to have them update the robbery response plan. This will help us have the most accurate and up to date information available. This would also be an excellent opportunity to have them review the policy. Unfortunately there are more times than not that the employee does not know the proper procedures, putting themselves and others in danger.

The Warren County uniform robbery response plan for financial institutions form has been mailed out to all departments. This should be taken to all financial institutions to be completed.

Once this form is completed, it can be hand delivered, mailed or faxed to the Communications Center so we can update our database and have the information readily available.
